Cookies

When you visit this website, we may place certain information on your computer or mobile device in the form of “cookies”, which allows us to automatically recognize you on your next visit.

You can choose to accept or reject cookies. Your options for managing which cookies can be placed or read by us on your computer or mobile device are provided below. If you do not accept the cookies that are defined as ‘Strictly Necessary’, you will not be able to visit this website. If you reject other cookies, some of our website's features or resources may not work properly and you may experience some convenience or functionality losses.

What is a Cookie?

Today, almost every website uses cookies. Like most websites, we also use cookies to offer you a better, faster and safer experience. A cookie is a small text file that is stored on your device (e.g. computer or mobile phone) when you visit a website. Cookies can be stored on your device through your browser during your first visit to a website. When you visit the same website again with the same device, your browser checks whether there is a cookie that is registered under the name of the website, and is stored on your device. If there is a record, it transmits the data in the record to the website you are visiting. In this way, the website understands that you visited the site before and determines the content to be sent to you accordingly.

Why are Cookies Used?

Some cookies enable the website to remember your preferences from your previous visits, allowing your future visits to provide a much more user-friendly and personalized experience.

In addition, while the links to third party websites on the website are subject to the privacy policies of such third parties, the Development Investment Bank of Turkey is not responsible for the privacy practices of those third parties, and it is hence recommended that the privacy policy of the website, the link of which is provided, be read when it is visited.

Common Types of Cookies

Cookies, whose main purpose is to provide convenience to users, are basically divided into four main groups:

Session Cookies: These are cookies that allow the utilization of various features such as transferring information between the internet pages and systemically remembering the information entered by the user, and are necessary for the proper functioning of the website functionalities.

Performance Cookies: These are cookies that collect information about the frequency of page visits, possible error messages, and the total time spent by the users on a given page as well as the users' usage patterns for the site, and are used to improve the performance of the website.

Functional Cookies: These are cookies that enable previously selected options to be reminded to the user for their convenience, and their goal is to provide advanced Internet features to the users within the scope of the website.

Advertising and Third Party Cookies: These are cookies of third party suppliers, which allow the use of some functions on the website and the advertisements to be tracked.

The Aim of Using Cookies

ASP.NET_SessionId - This is a standard cookie created by the ASP.NET Framework, to manage user sessions. No personal information is collected or stored through this cookie. Expiry: When the session ends

_ga - This is a cookie that is associated with Google Universal Analytics. It is used to distinguish unique users by assigning a randomly generated number as the client identifier. It is used to process visitor, session and campaign data for the analysis reports of sites. Expiry: 2 Years

_gat - This is associated with Google Universal Analytics - it limits the collection of data in high-traffic areas. Expiry: 1 Minute

_gid - This uniquely identifies a visitor during a single browser session and demonstrates that such visitor is an example of a target audience. Expiry: 1 Day

ajs_anonymous_id - This tracks the user activities. Expiry: 7 Months

ajs_user_id - This segments the user activities. Expiry: 1 Day

ASP.NET_SessionId - This is a standard cookie created by the ASP.NET Framework, to manage user sessions. No personal information is collected or stored through this cookie. Expiry: When the session ends

.AspNetCore.Antiforgery. - The random value that is created to ensure Cross Site Scripting security is stored in this cookie. Expiry: When the session ends

Kalkinma.Loan.Platform - This is an authentication cookie. Expiry: When the session ends

Controlling and Deleting Cookies

All you need to do to change your preferences for the use of cookies or to block or delete cookies, is to change the settings of your browser. Many browsers give you the option to accept or reject cookies, to accept only certain types of cookies, or to be alerted by the browser when a website requests to store cookies on your device, so that you can control the cookies. It is also possible to delete the cookies that are previously saved in your browser. The processes for checking or deleting cookies may vary depending on the browser you use. Instructions of some popular browsers for allowing, blocking or deleting cookies can be accessed from the links below.

What are your Rights Arising from the Law on the Protection of Personal Data?

We would like to remind you that you have the right to;

- a) learn whether your personal data is processed or not,
- b) request information if they have been processed,
- c) learn the purpose for their processing and whether they are used in accordance with the intended purpose,
- d) learn the domestic / foreign third parties to which they are transferred,
- e) request that they are corrected if they are processed incompletely / inaccurately,
- f) request that they are deleted / destroyed under the terms stipulated in Article 7 of KVKK (Law on the Protection of Personal Data),
- g) request that the transactions carried out under the above-listed subparagraphs (d) and (e), are notified to the third parties that they are transferred to,
- h) file an objection for an unfavorable consequence for you which resulted from the exclusive analysis of your data through automated systems,
- i) demand restitution in case you suffer damages due to their processing against KVKK, as per KVKK.
